Her nobility, Zein Bint Nasser, the adviser and member of the Board of Trustees of the Hashemite Fund for the Development of Jordanian Badia, Chairperson of the Advisory Committee for Nomads Health Project, assured that health care in the desert areas of Jordan poses a special challenge to health service providers because of the distances. She said in a speech read on behalf of Her, by the Governor of Mafraq, Mr. Ali Nassal in the final meeting of the health project workshop of the nomads, organized by the Faculty of Princess Salma Bint Abdullah of Nursing in collaboration with the Faculty of Nursing at the University of Philadelphia at Al-Bayt University, said that the government services are represented in the Ministry of Health and the Royal Medical Services. Health care is sparing no effort in providing adequate health care, within the material and human resources available, and said that it requires health strategy coordination to contribute to the integration and consolidation efforts," and here, " She says, "I like to come from officials, academics and community to adopt the recommendations of this project which I hope will be contributed to valuable clarification, evaluation or development of typical interventions in partnership with service providers to improve access to reproductive health care and health care for children and improve the quality of care provided."

The Director of the project, Dr. Jalian Handt of Britain showed



in her speech the importance of this project in the rural areas to assess the health status and behavior of researchers from health services and practices of nomadic communities in the area of reproductive health and the health of children and evaluation of care services. He provided thanks to the Ministry of Health and the Centre for Badia Research and Development, the University of Al al-Bayt and the University of Philadelphia.

The Dean of Princess Salma Faculty of Nursing, Dr. Omar Al-Rawajfeh pointed out that the concept of nursing has expanded and become more inclusive and nursing care has also become not only for competent persons, but for communities which have become an integral part of these nursing care. At a time when nursing has proved a remarkable development in the world in general and in this country in particular, the access to the needs of the community has become an urgent necessity. It became necessary to determine the data needs within the community and within the understanding of its components and its properties. It was therefore necessary to conduct scientific studies that provide accurate health databases to be relied upon to provide proper care for these communities.

He added that the participation of Princess Salma Faculty of Nursing in the Health Project of the Bedouins comes from the mission of the Faculty to offer services for the community and the need to work to bridge the gap between theoretical sciences in the nursing courses and the problems of the real community.

The closing meeting was attended by the Acting-Vice-President of the University Prof. Hashim Masaeed, the Vice President for Administrative and Financial Affairs, Jihad Al-Majali, Vice-President of the University for Faculties of Humanities, Prof. Nasser Al-Khawaldeh. The Workshop included two working sessions; the first chaired by Dr. Mohammed Bishtawi of Al-Bayt University, the Head of the research team Health Project of the Nomads in a paper on research methodology and its results. The second, chaired by Dr. Fadia Hasna, from the University of Philadelphia, with the participation of Dr. Adel Balbisi from the Ministry of Health and the Director of Al-Mafraq Health Directory, Dr Sulaiman Affash on the challenges and achievements of the health care system the Northern Badia. in

A Lecture on the line of family counseling in each House

At the invitation of the Faculty of Princess Salma Bint Abdullah of Nursing at Al-al-Bayt University the legal adviser of the Jordanian Women's Union, lawyer Manal Al-Nidami, and Rasha Khaza'aleh, the social worker of the Guest House of the Child in Irbid Branch, gave a lecture on the line of family counseling.

This lecture comes as of part the academic course, Community Health Nursing, taught at the University. Lawyer Manal Al- Nidami talked about the history of the Jordanian Women's Union which was founded in 1946 under the name of the Women's Union as a voluntary non-profitable foundation with a clear methodology and, where the Union provides several services, including dealing with social development to children and women. Al-Nidami has also focused on the most important programs offered by the Jordanian Women's Union and the program line of family counseling, which aims to enable Jordanian women



to face their problems and find appropriate solutions to the assistance of specialists from the European Union, in addition to the program of legal literacy, which aims to deliver legal information needed by any person as law of personal status and legal literacy in the community, and services also provide the health service in mobile clinics and litigation free service offering these services in strict confidence.

Meanwhile, the social worker, Rasha Khaza'aleh, talked about the program of the Guest House of the Child, which provides hosting services for the child and his separated parents in the Guest House legally; in addition to follow the mentoring program with parents to help with conflict resolution. She also talked about the line of family counseling, which aims to enlighten the conflicting parties of the reasons of conflict and provide solutions through social meetings between the parties in the presence of social workers.

At the end of the lecture directed by the Head of Community Health Nursing and Mental Health at the University, Dr. Mohammad Al-Bishtawi, an extensive dialogue between students and the two guests took place about the services of Jordanian Women's Union and the problems faced by society.





A Lecture on the parliamentary elections at the University

The lecture was attended by a number of faculty members and a number of University students.





Constructing a complex for students' activities at a cost of three million JDs at Al al-Bayt University



A cooperation agreement for constructing a complex for students' activities at a cost of up to three million, three hundred forty-three thousand, seven hundred and eighty JDs has been signed at Al-al-Bayt University.

It should be also noted that the duration of the completion of this project is (720) days.
