# New University President Assumes Responsibility

A Royal decree was issued on April 3, 2008 appointing Professor Nabil Shawagfeh President of AL al-Bayt University.

Professor Shawagfeh obtained the Bachelor's and Master's Degrees in Mathematics from the University of Jordan in 1977 and 1979 respectively, and the Doctoral degree in Applied Mathematics from Clarkson University/USA in 1983.

He occupied many administrative positions along with his teaching responsibilities before he became President of AL al-Bayt University. He served as Vice-President for Scientific Faculties of the University of Jordan. He was also Chairman of the Science Department at Philadelphia University and Director of the International Scientific Relations Office at the University of Jordan.

In 2004 - 2005, he served as Advisor to Jordan's Minister of Higher Eduction and Scientific Research, and in 2001, he was appointed Dean of Academic Research of the University of Jordan and from 1996 till 1998, he was Chairman of Mathematics Department at the same university.

He is recipient of Abdul-Hameed Shouman Prize for Young Arab Researchers for the year 1996 and his research and studies in the field of his specialization (BVP, Fractional Calculus, Special Function and Mathematics) have been published in refereed academic journals.



# Former University President Elected Deputy President of the International Islamic Fiqh Academy

Former President of AL al-Bayt University and State Advisor for Islamic and Religious Affairs Abdel Salam Abbadi was elected Deputy President of the International Islamic Fiqh Academy/Jeddah during his participation in the Academy's 18th session, which was held recently in Malaysia.

According to Professor Abbadi, the session had discussed a number of issues of concern to the Islamic nation including challenges facing Muslims such as Islamophobia and the poverty alleviation campaign in the Muslim world. Other discussed topics included characteristics of the civilizational approach in Islam, development of human resources in the Muslim world, role of Zakat Charity in combating poverty, rights and duties of Muslim women and contemporary medical issues.

#### The International Islamic Fiqh Academy

The International Islamic Fiqh Academy is a subsidiary organ of the Organization of the Islamic Conference (OIC). Created by the Third Islamic Summit Conference held in Makkah al-Mukarramah (Saudi Arabia) in January 1981, the Academy is based in Jeddah (Saudi Arabia).

Its members and experts are selected from among the best scholars and thinkers available in the Islamic world and Muslim minorities in non-Muslim

countries, in every field of knowledge (Islamic Fiqh, Science, Medicine, Economy and Culture, etc.).

#### Professor. Abdel Salam Abbadi

Born in Amman on March 10, 1943, Professor. Abdel Salam Abbadi obtained the Bachelor's degree in Islamic Shari'a (Law) from the University of Damascus, the Higher Diploma in Islamic History from the University of Cairo, and the Master's and Doctoral degrees in Comparative Jurisprudence (Fiqh) from Al-Azhar University in 1972.

His research and studies in the field of his specialization have been published in refereed academic journals.

Early in his career, Dr. Abbadi served in the field of education and educational counseling at the Ministry of Education and the Ministry of Awqaf and Islamic Affairs. He then joined the University of Jordan and the Yarmouk University as teaching staff member in the Faculty of Shari'a (Islamic Studies). He also assumed teaching and lecturing in the field of his specialization at the Institute of Banking Studies and other academic institutions in Jordan.

At the University of Jordan, and besides his teaching tasks, Dr. Abbadi was Chairman of the Department of Jurisprudence and Foundation from 1975 – 1978, and Dean of Student Affairs from 1978 – 1982. He was then appointed Under-Secretary of the Ministry of Awqaf and Islamic Affairs from 1982 – 1988 and Director General of the Management and Development of Orphans Fund Corporation.

Dr. Abbadi served as President of AL al-Bayt University from December 5, 2004 – April 7, 2005, when he was re-appointed Minister of Awqaf and Islamic Affairs. He served as President of AL al-Bayt University for another term from January 1, 2007 – April 2, 200).

Dr. Abbadi serves, on voluntary basis, as Under-Secretary of the Jordan Hashemite Charity Organization for Arab and Muslim Relief, Development and Cooperation.

He represents Jordan in the Islamic Fiqh Academy of the Organization of the Islamic Conference, in addition to his membership in a number of local, regional, and international councils and committees.

An Agreement of Cooperation was reached between AL al-Bayt University and the Lumière University Lyon 2 in France.

In a brief comment following the signing of the Agreement, President Shawaqfeh said that this Agreement is part of a series of extended efforts on the part of the University to construct bridges of constructive cooperation with Arab and foreign countries worldwide.

To this end, the University has made it a point to provide them withafree shuttle service on campus to make sure that they commute easily from one faculty to another in due time for their lectures. A feasible solution for their transportation problem off campus is to see the light soon, he added.

To improve the quality of its infrastructure and services, work is now in progress for the establishment of shaded and umbrella-covered areas for students. These areas are intended to protect students from rain during the winter and heat during the summer. Asphalted and shortcut roads on campus are also part of these projects which aim at expediting students' commutation from one faculty to another on campus.

Dr. Shawagfeh referred to a number of vital projects that the University has recently tendered like the New University Gate which will link the University campus with the city of Mafraq, as well as a Liaison Office for the University and a Centre for Consultation and Studies in the capital city Amman, and expansion of al-Hashimiyyah Library services.

# **Omani Sheikh Lectures on 'Ijtihad'**



During his presence in Jordan to attend the international seminar on Al Otubi Al Sohari, His Eminence Sheikh Ahmed Bin Hamad Al Khalili, the Grand Mufti of the Sultanate of Oman delivered a lecture on 'Ijtihad'.

Explaining the term, Sheikh Al-Khalil said that 'Ijtihad', according to the lexicographers, is derived from 'juhd', which means employment of effort or endeavour in perOmani Mufti explaining ijtihad

forming a certain activity. Ijtihad Arabic is a technical term of Islamic law that describes the process of making a legal decision by independent interpretation of the legal sources, the Qur'an and the Sunnah. The opposite of ijtihad is taqlid, Arabic for «imitation». A person who applies ijtihad is called a mujtahid, and traditionally had to be a scholar of Islamic law, an Islamic lawyer or alim.

To become a mujtahid in theological terms is similar to having a doctorate in divinity in Islamic kalam, or in legal terms to reaching the status of a high or supreme court judge.

A question and answer period followed at the end of the lecture which was attended by faculty members and students.

## **Energy-related Issues Addressed on Institute of the Earth and Environmental Sciences Scientific Day**

Speakers on the inauguration session included Mr. Hans Christian, the Commercial Attaché at the Embassy of the Federal Republic of Germany in Jordan who reviewed the German experience in resorting to alternative energy resources that would easily be applied in Jordan.

Dean of the Higher Institute of the Earth and Environmental Sciences Dr. Adnan Harahsheh noted that the institute aspires to serve as a Centre of Excellence in relation to attaining feasible and optimum solutions for energy and other water and environmental-related problems in Jordan. ## Food for Thought



I s

there such a thing as brain food? Well, you'd think so. You are, after all, what you eat. It's an astonishing insight. If you think about it, your body, everything that you chemically are, is made of the foods you've taken in over the course of your life. How else could it be?

But with this said, or read, somehow I hope you know intuitively that eating page after page of crossword puzzles may not do much to improve your brain or your mental health, but working the puzzles, working your brain, probably does improve your brain's faculties.

Our brains are more than 50 percent fat. Wow. So calling someone a "fat-head" may not be all bad. But, a diet heavy in fat has been generally shown to be bad for your brain. It's not obvious why this is, but in general, the farther blood has to flow through narrow passages (for example, a few detours through extra fat cells), the harder your body has to work to get any task done, brain tasks included.

Most nerves in your body have an insulating layer of fat around them. This sheath, as it's often called, prevents your nerves from literally, electrically short-circuiting. So, it is reasoned the fat in your head keeps your brain cells at a safe electrical distance from one another.

#### **Smart fats**

Successful athletes pay a great deal of attention to what they eat. So, intuitively you might suspect that there are things in your diet that might help you think. For example, there has been a great deal in the news in the last few years about omega-3 oils. Some studies with rats suggest that a diet rich in omega-3 oils helps their brains heal after an injury and generally helps them solve mazes. It could be a memory enhancer.

Omega-3 might better be pronounced "omega minus three." It refers to the molecule's chemistry. One end of a fat molecule is the alpha end; the other is the omega end. Alpha and omega being the first and last letters of the Greek alphabet. So, omega-3 means three bonds away from the far end of the molecule. The alpha end in this case, is the end with double carbon bonds. Carbon has the remarkable ability to bond with itself in a single, double, or triple bond. It's the element that makes life go, and we refer to its chemistry as "organic," meaning having to do with organisms.

You may have heard the term "saturated" fat. That means every available chemical bond hanging off of a carbon atom is saturated with a hydrogen atom. Well in this example, omega-3 oil is "polyunsaturated." Poly = mul-

tiple pairs of double bonded



carbon atoms. Unsaturated = not every carbon [atom] is "saturated" with hydrogen atoms.

Fat like this is in your brain. What's not obvious is the idea that taking some in through your mouth, particularly a huge amount that would be hard to get in nature, guarantees that it will find its way to your brain. After all, it has to pass through the hydrochloric acid in your stomach.

#### **Herbal supplements**

By way of another example, ginseng is a root that many believe "enhances concentration" and "mental stamina." If that were true, wouldn't every chess champion and Nobel laureate want to walk around with a canteen full of ginseng extract or tea? Wouldn't they all feel a need, akin to hunger? Wouldn't they have done this since the Xia Dynasty (circa four thousand years ago)?

There may be a huge effect that overwhelms or masks any brain chemistry: one's mental focus or concentration. If you're paying attention, it seems like you have a better chance of, for example, remembering a stranger's name, or a directions to an unfamiliar destination. If you're not, uh ... paying attention, well, then ... Where were we?

In general, I encourage all readers to consider claims associated with brain vitamins or drugs. These things almost always claim to provide you with something extra, something you can't get in nature. Many of these products are not sold as drugs per se, nor are they sold as food. Instead, they're often called "diet supplements"; they're to add to what you eat. Read carefully in the literature associated with diet supplements touted as being good for your thoughts; there are phrases like "extra alertness" and "memory function"--vague on even the most insightful day.

But, I've got a feeling that if you eat a balanced, what nowadays is called a Mediterranean diet, you'll get all the brain food you need. Such a diet includes vegetables and fish, things that contain brain chemicals such as omega-3, in a form that your body has evolved to handle. If you take excessive amounts of these chemicals, you're probably just sending any excess above what your body can absorb down the toilet. And if you're fat, it probably won't help your brain. Get rest. Eat right. Think well.
